Member Spotlight: KSSC Makes Decisions

In the spotlight this month is all of us! More precisely, how we make decisions at our membership meetings. One of the revisions in our bylaws, is that the membership may choose to run our meetings by Consensus Decision-Making. (Those very serious things such as discipline, dissolution, elections, and amendments, will always be governed by the current edition of Robert's Rules of Order.) So TT is putting Consensus Decision-Making (we'll call it consensus to be concise) in the Spotlight.

A Brief Explanation of Consensus Decision Making

Consensus decision making is a creative and dynamic way of reaching agreement between all members of a group. Instead of simply voting for an item and having the majority of the group getting their way, a consensus group is committed to finding solutions that everyone actively supports — or at least can live with. This makes sure that all opinions, ideas and concerns are taken into account. By listening closely to each other, the group aims to come up with proposals that work for everyone.

Consensus is neither compromise nor unanimity — it aims to go further by weaving together everyone's best ideas and most important concerns — a process that often results in surprising and creative solutions, inspiring both the individual and the group as whole. What does all this mean for our meetings? Well, first let's agree that this is a new process to many of us, and we'll need a little time to learn just what works best for KSSC. The process can serve us very well if we are faced with complex, or complicated issues. On the 'everyday stuff' it can mean we can save some time without the formality of motions, seconds, and votes. Remember that the goal is that all members of our group need to be heard if they have something to say, and all members can offer ideas and ways toward a solution.

In practice, we'll introduce a topic and discuss its key questions. Members will offer ideas and insights, Then though discussion, we will develop a solution. Then we'll pose a questions such as, "Is this a solution that we all can live with?" While there are multiple tools to get at an answer, in a group as small as ours a quick 'head shake' is usually all that is needed.

Part of the idea is that we get through our business more efficiently, leaving us more time for education topics, sharing, and talking Shelties!

<u>How Does KSSC Elect Its Officers and Board at Large Members?</u> Explanation of the Process; Committee's Slate; Call for additional Nominations

The KSSC Bylaws provides for the election of directors and officers to be held at the Annual Meeting of the club in April. In advance of those elections, it lays out these steps for the nomination process:

- I. Before or during the month of January, the board will select a nomination committee of three members, not more than one of whom is a member of the board.
- 2. The committee will meet and may nominate up to three candidates for each officer and board member at large position; and will get the consent of each person nominated.
- 3. The committee will report nominations to the board no later than January 31. That list of nominees will be included in the February newsletter as notification to the membership.

(Nominations & Elections Continued)

- 4. Nominations will be requested from the membership in the February issue of the newsletter and member only area of the website. Additional nominations may be made through February 28.
- 5. No person may be a candidate for more than one office. Additional nominations may be made only from among those members who have not accepted a nomination of the Nominating Committee.
- 6. A final slate of candidates will be compiled from the Nominating Committee's work plus any additional nominations from the membership. The membership will be notified in writing of the slated candidates not less than two weeks before the annual meeting.
- 7. Voting will take place by secret ballot at the Annual Meeting in April. The nominated candidate receiving the greatest number of votes for each position will be declared elected.

Steps 1-4 are completed with the publication this Toonie Tails.

A call for additional nominations from members will be made at the February 23rd meeting. If you choose to nominate a member at that meeting, make sure that person will accept the nomination (if he/she will not be at the meeting, you will need a written statement of acceptance from the member.)

If you will not be at the February meeting, you may submit a nomination to the board by sending it to secretary@kyinssc.org. Please remember that additional nominations must be accompanied by a statement from the nominee that they accept and are willing to serve if elected. Additional nominations may be made until February 28th.
